### Texas Government Code, Section 659.026(3)(b)(3) – Executive Staff Compensation

The Texas Southern University Board of Regents sets the initial salary and conditions of employment for board-appointed positions. Board-appointed positions include the executive staff positions of Vice Presidents. Such appointments are recommended by the President, and confirmed by the Board. The salaries of other executive staff positions are established by the President and are based on multiple factors, which may include, but are not limited to: performance;

complexity of work; education and professional experience required for the position; scope of responsibility; and where the information is available, salaries for executive staff in similar positions at comparable institutions/agencies.

**Texas Government Code, Section 659.026(3)(b)(4) – Executive Staff Supplement Eligibility**

Executive staff are eligible for a salary supplement in accordance with TSU policy. These salary supplements do not include gifts as defined by the Texas Government Code Sec. 659.0201.
